  - f. Names of persons controlling the entity (other than owners or share holders)
  - g. Tax Identification Number (TIN) issued to the entity by FRCA

3. One Passport size photograph and identification documents of Owners, Controlling persons and authorised signatories.
4. Current and valid passport or any travel document issued by a foreign government or recognised international organisation
5. Current and valid work, business or other permit or visa issued by the Fiji Immigration Department.

### Additional Information

- The account will be classified to Dormant if there is no customer induced debit transactions in the account for 12 months. Once the account is classified as dormant the customer induced debit transactions in the account are allowed on submission of written request by the customer to the branch where account is maintained.
