2. Identification Documents in support for verification of Customers' (Legal Entities) in respect of following Details.
 - a. Name of Customer
 - b. Legal Form of entry
 - c. Date of Registration
 - d. Business Address
 - e. Name of Principal Owners / Share Holders
 - f. Name of persons controlling the entity (other than owners or share holders)
 - g. Tax Identification Number (TIN) issued to the entity by FRCA
3. One Passport size photograph and identification documents of Owners, Controlling persons and authorised signatories.

4. Minimum Deposit \$500 in the Branch where account is to be opened.

Additional Information

- Minimum balance of \$500 to be maintained in the account to avoid minimum balance charges.
- The account will be classified to Dormant if there is no customer induced transactions in the account for 12 months. Once the account is classified as dormant the customer induced debit transactions in the account are allowed on submission of written request by the customer to the branch where account is maintained.
- Customer can close account by submitting written request to the Branch where account is maintained. All unused Cheques should be surrendered while closing account.
